Article 1:(1) A competitive examination for the recruitment of 30 (Chrty) students (external candidates only), into Cycle "A" of the Revenue Services Division of ENAM, is hereby announced for 2024/2025 academic year.

(3) The syllabus for the examination is appended to this order.

(4) The choice of section shall be made by candidates when submitting their files.

Article 2: The examination shall be open to persons who fulfil the following requirements:

fulfil the general requirements for employment into the public service

- be holder of a Bachelor's degree in Higher Education in Cameroon or Professional Bachelor's degree in Law, Economic Sciences, Social Sciences (in relation with the Section applied for) and in Management obtain in Cameroon, or of a certificate issued by a foreign university and recognized as equivalent by the Minister in charge of Higher Education;
- be at least 17 (seventeen) years of age and thirty two (32) years of age at most, as at 1st January 2024;
- however, persons with disabilities who are holders of a National Disability Card issued by the competent authorities, may benefit from age exemption for a maximum of 5 (five) years above the age limit provided above, in accordance with Order No. 040/PM of 19 May 2022 mentioned above.

NB: Established civil servants of any category are not authorized to compete.

Article 3: (1) Registration forms can be downloaded on ENAM's website at the following address: www.enam.cm

- (2) Registration fees are 25000 francs CFA for both external and internal candidates.
- (3) Candidates shall pay their registration fees in cash against receipt at any BICEC branches.
- (4) All documents shall be submitted either in ENAM or at the Regional Delegations of the Ministry of the Public Service and Administrative Reform excluding the Centre Regional Delegation.
- (5) Application files shall either be submitted at ENAM for candidates in the Centre Region or at the Regional Delegations of the Ministry of the Public Service and Administrative Reform not later than **Friday 09 August 2024**.
 - **(6)** The application files referred to in paragraph (5) above shall include the following documents:
 - an envelope bearing a 1500 francs CFA stamp;
 - a registration form bearing a 1500 francs CFA fiscal stamp, previously downloaded from the ENAM website: www.enam.cm;

ah attestation of presentation of the original of the GCE A/L or an equivalent diploma allowing the candidate to get access into higher education signed by the Governor of the Region, the Senior Divisional Officer or the Divisional Officer;

a receipt showing proof of payment of registration fees for the competitive examination issued by BICEC;

certificate of non-conviction of not more than 03 (three) months old by the date of submission of file and signed by the competent judicial authorities;

- a medical certificate of not more than 03 (three) months old by the date of submission of file and signed by a public sector medical practitioner;

- a certified true copy of a birth certificate - **handwritten or typed-** signed by the competent administrative or council authorities;

<u>N.B.</u> Any incomplete file or file containing forged or falsified documents shall be rejected.

(7) The list of candidates authorized to sit this competitive examination shall be posted at ENAM latest **Wednesday 11 September 2024**.

N.B. The publication of the list shall serve as individual notification to candidates.




