- Mindful of Order No.040/PM of 19 May 2022 to lay down terms and conditions for granting age exemption to persons with disabilities during government competitive examinations and recruitment into the Public
- Mindful of Order No.0004831/MINFOPRA of 10 October 2012 to regulate Studies and Schooling in the Administrative and Revenue Services Divisions of the National School of Administration and Magistracy (ENAM),

## **HEREBY ORDERS AS FOLLOWS:**

Article 1:(1) A competitive examination for the recruitment of 40 (forty) students into Cycle "B" of the Revenue Services Division of ENAM, is hereby announced for the 2024/2025 academic year.

(4) The moice of section shall be made by candidate when submitting their application files.


Article 2: The examination shall be open to persons who fulfil the following requirements:

- (1) fulfil the general requirements for employment into the Public Service;
- (2) be holder of a Baccalaureate diploma or of the GCE-A/L in at least two subjects in one sitting excluding "Religious Knowledge", the "Capacité en Droit" or any other foreign equivalent certificate, recognized by the Minister in charge of Higher Education;
- (3) be at least 17 (seventeen) years of age and 32 (thirty-two) years of age, at most, as at 1stJanuary 2024;
- (4) however, persons with disabilities who are holders of a National Disability Card issued by the competent authorities, may benefit from age exemption for a maximum of 5 (five) years above the age limit provided above, in accordance with Order No. 040/PM of 19 May 2022 mentioned above.

NB: Established civil servants are not authorized to apply.

Article 3: (1) Application forms can be downloaded at ENAM's website at the following address: (www.enam.cm).

- (2) Examination fee amounts to 25000 francs FCFA (twenty-five thousand CFA francs)
- (3) Candidates shall pay their examination fees in each against receipt at any BICEC branches.
- (4) All documents shall be submitted either at ENAM or at the Regional Delegations of the Ministry of the Public Service and Administrative Reform excluding those of the Centre Region.
- (5) Application forms shall either be submitted at ENAM for applicants in the Centre Region or at the Regional Delegations of the Ministry of the Public Service and Administrative Reform not later than **Friday 9 August 2024.** 
  - (6) Candidates' application files shall comprise the following documents:
    - an envelope bearing a 1500 francs FCFA stamp;
    - a registration form bearing a 1500 francs FCFA fiscal stamp, previously downloaded from the ENAM website (www.enam.cm);
    - a certified true copy of the required certificate;
    - an attestation of the presentation of the original of the required certificate signed by the Governor of the Region, the Senior Divisional Officer or the Divisional Officer:
    - a receipt showing proof of payment of registration fees for the competitive examination issued by BICEC;
    - a certificate of non-conviction of not more than 03 (three) months old by the date of submission of file and signed by the competent judicial authorities;
    - a medical certificate of not more than 03 (three) months old by the date of submission critical and signed by a public sector medical practition.
    - a certified to copy of a birth certificate handwritten or type signed by the competent administrative or council authorities.



- N.B. Any incomplete file or file containing forged or falsified documents shall be rejected.
  - (7) The list of candidates authorized to sit this competitive examination shall be published at ENAM latest **Wednesday 21 August 2024**.

N.B: The publication of the list shall serve as individual notification to candidates.


