To announce the competitive entrance examination for the recruitment of **fifty (50) students** into cycle 'B' of the Administrative Division of the National School of Administration and Magistracy (ENAM), for the 2024/2025 academic year.

#### THE MINISTER OF THE PUBLIC SERVICE AND ADMINISTRATIVE REFORM,

- Mindful of the Constitution;
- Mindful of Law No. n°2017/010 of 12 July 2017 to lay down the general Rules and Regulations of State Establishments;
- Mindful of Decree No. 75/774 of 18 December 1975 regulating the special status of Civil Servants of General Administration;
- Mindful of Decree No. 75/788 of 18 December 1975 regulating the special status of civil servants of the Public Health and Social Affairs;
- Mindful of Decree No. 75/791 of 18 December 1975 regulating the special status of civil servants of the Labour and Social Security, amended and supplemented by Decree No. 77/243 of 15 July 1977;
- Mindful of Decree No. 94/199 of 7 October 1994 to lay down the General Rules and Regulations of the Public Service, and subsequent amendments thereto;
- Mindful of Decree No. 2011/408 of 9 December 2011 to organise the Government amended and supplemented by Decree No. 2018/190 of 2 March 2018;
- Mindful of Decree No. 2012/537 of 19 November 2012 to organise the Ministry of Public Service and Administrative Reform:
- Mindful of Decree No. 2018/191 of 2 March 2018 to reshuffle the Government
- Mindful of Decree No. 2018/240 of 9 April 2018 to reorganise the National School of Administration and Magistracy (ENAM);
- Mindful of Decree No. 2000/696/PM of 13 September 2000 to lay down the general rules and regulations for government Competitive Entrance Examinations;
- Mindful of Order No. 040/PM of 19 May 2022 to lay down terms and conditions for granting age exemption to persons with disabilities during competitive examinations and recruitment into public service;
- Mindful of Order No. 0004831/MINFOPRA of 10 October 2012 regulating Studies and Schooling in the Administrative and Financial Divisions of the National School of Administration and Magistracy (ENAM),

# **HEREBY ORDERS AS FOLLOWS:**

<u>Article 1</u>: (1) A competitive entrance examination for the recruitment of **fifty** (50) students into Cycle 'B' of the Administrative Division of ENAM is hereby announced for the 2024/2025 academic year.

(2) The number of available places is distributed as follows:

- (3) The syllabus for the examination is appended to this order.
- (4) Candidates shall choose their sections while submitting their application files.

Article 2: The examination shall be open to persons who fulfil the following requirements:

- (1) fulfil the general requirements for employment into the public service;
- (2) be a holder of either the 'Baccalaureate' or the GCE 'A' Level with at least two papers passed in one sitting excluding Religious Knowledge, a 'capacité en droit' or any other foreign equivalent certificate, recognised by the Minister of Higher Education;
- (3) be at least 17 (seventeen) years of age, and 32 (thirty-two) years at most, as from 1 January 2024;
- (4) However, disabled persons, holders of a National Disability Card issued by the competent authorities, may benefit from an age limit waiver for a maximum of 5 (five) years, over the age limit set above, in accordance with the above-mentioned Order No. 040/PM of 19 May 2022.

# N.B.: Established civil servants are not allowed to apply.

Article 3: (1) Application forms can be downloaded on ENAM's website at the following address: www.enam.cm.

- (2) Examination fee amounts to 25000 francs CFA (twenty-five thousand CFA francs)
- (3) Candidates shall pay their registration fees in cash against receipt at BICEC branches.
- (4) Candidates may submit their applications in return for a receipt directly to ENAM or to the Regional Delegations of the Public Service and Administrative Reform, except for the Centre Regional Delegation.
- (5) Application forms shall be submitted at ENAM or the Regional Delegations of the Ministry of Public Service and Administrative Reform not later than Friday 9 August 2024.
- (6) Candidates' application files shall comprise the following documents:
  - an envelope bearing a 1500 francs CFA stamp;
  - application form bearing a 1500 francs CFA fiscal stamp, previously downloaded from ENAM website (www.enam.cm);
  - certified true copy of the required certificate;

- attestation of presentation of the original of the required certificate signed by the overnor, the Senior Divisional Officer or Divisional Officer;
- receipt attesting payment of the registration fee issued by BICEC;
- certificate of non conviction of not more than 3 (three) months issued by the competent legal authorities;
  - -a medical certificate of not more than 3 (three) months signed by a public sector medical practitioner;
- a certified true copy of the birth certificate handwritten or typed signed by the competent administrative or council authorities.

N.B.: Any incomplete files or files containing forged or falsified documents shall be rejected.

(7) The list of candidates authorised to sit the competitive entrance examination shall be posted at ENAM not later than **Wednesday 28 August 2024**.

**N.B.:** The publication of the list shall serve as individual notification to candidates.


